## **PSRS/PEERS of MO Retirees to Expect a** 5% COLA in 2023!

Eligible PSRS/PEERS of Missouri retirees should look forward to a 5% increase on their January 31, 2023 pension deposit. The PSRS/PEERS Board of Trustees is expected to approve the cost-of-living adjustment (COLA) at their October meeting. In 2016, the Board adopted a COLA policy as part of the system's funding policy. This is great news, especially following the 5% COLA eligible retirees received in 2022. COLA's allow our retirees to maintain their current standard of living and provides adequate retirement to Missouri's

educators and education personnel in retirement.

PSRS/PEERS Board of Trustees uses the CPI-U to help determine COLA amount. The CPI-U as of June 30th is 9.1 % but PSRS/PEERS Board policy and Missouri state law set a maximum COLA of 5%.

MRTA is working to protect the COLA for our retirees and we will not stop working for a better COLA policy for all retirees in Kansas City, St. Louis, and statewide.

It didn't take long for her to understand how important MRTA was to retired teachers, as well as to active teachers and to the state in general. Our teachers and education personnel are the heart of our local communities. They care about their

students, their families, their schools, and their towns. MRTA members advocate for public education and retired

teachers. "Our retirees understand

what our teachers deal with every day in the classroom and we have the time and knowledge to advocate for them."

During her time with MRTA, Nancy has held multiple leadership positions. At the

unit level, she "held every position but secretary and treasurer." She then spent 11 years as Region 8 vice president and served as MRTA vice president, before becoming president. She even helped start a new unit in her region, which is now one of MRTA's best units!

She describes her journey to board presidency a 'progression' and traces her desire to be a part of MRTA leadership back to one of the first statewide meetings she attended.

"I was so impressed by the fact that they gave 11 teachers scholarships of \$1,000 each," she said. "This was before Missouri Retired Teachers Foundation (MRTF) grants had

started. And at that time, we only had 5,000 or 6,000 members. But here was this group of people who valued public education and public school teachers so much that they would donate so much money – I was blown away."

For Nancy, awarding grants is one of her favorite parts of her job as president. "I get

lots of hugs!" she said. But for her, it is also a golden opportunity to talk about the value and importance of the association. "It's harder than ever to get into the schools and talk with working teachers about the importance of joining MRTA," she said. "The grant program allows us to meet our active teachers in all of our school districts and talk to them about the value of staying informed about public education and their retirement."

Another part of the duties of president that Nancy also loves is visiting the units and regions on a road trip



throughout Missouri. "As president, you go to these events and you look out over this sea of faces," she reflected. "I've been to every part of the state, and it's always different. It's such a diverse state. But as educators, we have so much in common. I can sit with a teacher that I've never met, and in less than 10

minutes, I can find common ground and exchange shared experiences." She added, "As a leader, I think I've inspired people to join MRTA at the local level as well as at the state level."

"I have traveled the state with Nancy," said Maria Walden, MRTA Executive Director. "Nancy has so much energy. She has the ability to relate to all of our members whether they are newly retired or a member who has been retired for years."

Nancy lives in Valley Park, Missouri with her son and her pet cat. When asked about her plans post-presidency, Nancy leaves no doubt that she will continue to be a force within the association. "I'm hoping to continue to be active," she said and expressed a desire to settle into another leadership role with the group. She adds with a






